The undersigned voluntarily assumes all risk of loss, damage, and/or injury, that may be sustained while participating in the Activity and expressly waives and relinquishes any claim for negligence of any type whatsoever against H.C.E.F. its staff, officers, participants, volunteers, all stores at which the tour stops, and all sponsors. The undersigned agrees to save and hold harmless the H.C.E.F. its staff, officers, participants, volunteers, all stores at which the tour stops and all sponsors from any and all claims resulting while participating in the Activity or while on route to or from any premises upon which the Activity may take place.
